The details provided and the information in the Annex show they were appropriate for the triangulation, analysis and assessments of GE and HR specific results. The sampling strategy is well described but more details could have been provided regarding the selection of the site visits. The number of people consulted seems appropriate for the scope of the evaluation. The report contains a good description of the tools and processes used for data collecting taking ethics and gender into consideration. This includes approval of the tools by ethical review boards of the respective UN organizations and the adoption of ethical standards for interviewing survivors or GBV and children. Explanations about limitations faced by the evaluation are also included.

Even though an assessment of data on gender related results was not referred to, the scope refers to Gender, and the evaluation objectives are all gender-related. Evaluation questions related to gender/HR are included. Gender is not a standalone criteria but it is mainstreamed. It is clear that the methodology used was fully gender-responsive. The methodology uses mixed data collection methods, appropriate for GEEW data collection. The sampling frame refers to focus on beneficiary/target groups and the use of confidentiality and separate interviews/ focus groups tools for men and women. The report contains a good description of the tools and processes used for data collecting taking ethics and gender into consideration. This includes approval of the tools by ethical review boards of the respective UN organizations and the adoption of ethical standards for interviewing survivors or GBV and children. The evaluation fully reflects gender analysis. The background section explains the gender issues the joint project is to address. The report assesses gender related outcomes and findings include gender perspective. The findings are well articulated, and systematically address the evaluation questions and criteria. GEEW aspects also included in conclusions and recommendations. The Conclusions and recommendations are well formulated and are directly connected to the findings, providing clear responses to the evaluation criteria.
