Lessons learned could be formulated to better describe their significance to similar initiatives in other contexts, and recommendaitons could be more actionable.

Executive Feedback on Parameter 2	The object of evaluation and the context in which it operates are exceptionally well described. The section includes specific information about the initiative's scale, budget, objectives, and theory of change. The context section describes the international and national environments around gender-responsive budgeting, provides detailed information on the socio-economic and political contexts within each primary country, and identifies opportunities and challenges for GRB in ECA. Additionally, stakeholders and their contributions (including rights holders and duty-bearers) are explicitly identified within a dedicated sub-section.				
PARAMETER 2: PURPOSE, OBJECTIVES AND SCOPE			PARAMETER 2	Very Good	
The evaluation purpose is well explained by highlighting which stakeholders will use the information generated by the evaluation and to what ends. The report also provides a good excellent description of the evaluation objectives and scope. It also follows good practice by explaining why the standard OECD/DAC evaluation criterion of "impact" was not appropriate for this evaluation.

The evaluation used a participatory theory based evaluation methodology, drawing on Collaborative Outcomes Reporting Technique (CORT). Methodological choices, including the design and data collection methods and sources, are well described and justified. The evaluation was highly participatory and used gender sensitive methodological choices. It ensured that a diverse set of stakeholder views were captured. This being said, the report annexes that are said to contain a list of data sources, additional information on ethics, the evaluation matrix, and copies of the evaluation tools are not retrievable. While the report mentions that case study countries were purposefully sampled, there no justification provided for why these particular countries were selected.

They are forward-looking and provide important information around challenges and opportunities. Important lessons learned are presented and are correctly identified and presented. However, they could include a more in-depth discussion around how they could be useful or applied to similar initiatives in other contexts.

Executive Feedback on PARAMETER 6	Recommendations are supported by the evaluation evidence and reflect a good understanding of the programming context. They were developed in consultation with stakeholders, which reflects good practice. While they are numbered, the order in which they should be implemented or their priority order is not explicitly clear to the reader. Additionally, they could be strengthened by providing more specific details and suggestions on how they could be implemented.

Executive Feedback on PARAMETER 7	GEEW is specifically included in the scope and objectives. The evaluation included a specific GE/HR criterion, and also appear to have mainstreamed GE across the evaluation questions. The evaluation applied Collaborative Outcomes Reporting Technique and Outomes Harvetsing, including participatory data analysis and validation processes. The findings, conclusions and recommendations all explicitly include gender analysis at multiple levels (structural and instrumental).
