The conclusions are strong overall but tend to focus primarily on the project's strengths and could benefit from providing more information on how the project could be improved. Recommendations are based on the findings and conclusions but need to better identify the target group for action and should be presented in priority order. The evaluation demonstrates best practices in its excellent integration of GEEW and human rights principles.

Executive Feedback on Parameter 2  The evaluation's purpose, objectives, and scope are sufficiently clear to guide the evaluation. Information provided to explain how GEEW and human rights were included in the evaluation process is particularly strong. While the evaluation identifies the evaluation users, the report does not explicitly state how the information obtained through the evaluation will be used by the end users.

Executive Feedback on Parameter 3  The evaluation is based on a strong mix-methods methodology that included a diverse range of beneficiaries, non-beneficiaries, and stakeholders. Information on the data collection methods, data sources, sampling frame, stakeholder consultation, human rights and GEEW considerations, and ethics is complete. The report is also strong at justifying methodological choices and at presenting limitations.
